_____/ ____ A third party is arranging the travel logistics of the Field Trip. Student and/or Parent(s) may be required to sign an agreement or contract with the third party. Student and Parent(s) acknowledge and understand if the third party requires an agreement or contract to be signed by the Student and/or Parent(s), the parties to such an agreement or contract are the Student and Parent(s) and the third party. The School District is not a party to any such agreement or contract and has no authority to change or modify the terms before or after the agreement or contract is executed. Furthermore, the Student and Parent(s) warrant that they have or will read the terms of any such agreement or contract.

_____/ ____ The School District may enter into an agreement with the third-party travel company, which agreement may include terms regarding cancellation and refund policies that Student and/or Parent(s) may be subject to in the event the Field Trip is cancelled for any reason, including a decision by the District. If the terms of the agreement are not clear in documentation provided to Student and/or Parent(s), the District encourages Student and/or Parent(s) to obtain the terms of the agreement from the Trip Sponsor.

_____/ ____ The School District shall have the authority to delay, cancel, or terminate the Field Trip in consideration of student safety for reasons including, but not limited to, natural disasters, pandemics, epidemics or other health crisis, domestic or international political developments and/or U.S. State Department travel warnings.

_____/ ____ If the trip is cancelled for any reason or if Student is unable to travel, funds will be refunded in accordance with the refund policy of the third party. The School District has no control over these

policies and cannot require the third party to issue refunds beyond those stated in any agreements signed by Student and/or Parent(s).

_____ / _____ At the time of the Field Trip, Student shall be a currently enrolled in the District or have graduated in the immediately preceding academic school year and earned or paid for the Field Trip while an enrolled student.

_____ / _____ Student shall be subject to the School District code of Conduct at all times related to Student's participation in the Field Trip. As a condition of participating in the Field Trip, Student must comply with all instructions and safety precautions communicated by School District officials. In the event of Student's repeated or serious violation of the Code of Conduct and/or failure to comply with instructions or safety precautions communicated by School District officials, Student's participation in the Field Trip may be terminated early and Parent(s) may be required to pay all costs of sending Student home if deemed necessary by the trip sponsor or other School District official.

_____ / _____ Student will be required to follow all CDC guidelines, local ordinances, and District policies and procedures regarding facial coverings, testing, quarantine, isolation, social distancing and other health-related ordinances for COVID-19 or any other communicable diseases. In the event of Student's repeated or serious violation of these guidelines, ordinances, policies and procedures, Student's participation in the Field Trip may be terminated early and Parent(s) may be required to pay all costs of sending Student home if deemed necessary by the trip sponsor or other School District official.
